For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, I, the above identified parent/legal guardian of the above identified child under age nineteen (hereinafter "Minor"), hereby agree as follows:

Treatment Consent. In my own behalf and on behalf of Minor, I hereby grant the permission necessary to allow Minor to participate at the Jr. Ski Retreat ("Event"), to be conducted by, sponsored by or in connection with Barev Centre ("Barev"). I acknowledge and agree, in my own behalf and on behalf of the Minor, that such participation subjects Minor to the possibility of physical illness or injury and that I, in my own behalf and on behalf of the Minor, acknowledge that the Minor is assuming the risk of such illness or injury by participating in the Event. In the event of such illness or injury, I authorize any adult acting on behalf of Barev to obtain necessary medical treatment for the Minor and hereby, in my own behalf and on behalf of the Minor, release and hold harmless Barev, any other owner on whose premises the Event will occur and their respective officers, representatives, members, agents, employees and any other adult acting on their behalf (hereinafter collectively "Releasees") in the exercise of this authority. I further acknowledge and understand that I will be responsible for any and all medical, hospital, ambulance and related expenses that may be incurred on behalf of the Minor for any illness or injury that the Minor may sustain during the Event.

Release & Waiver. I, in my own behalf and on behalf of the Minor, further agree to release and to hold harmless Releasees from any and all liability for negligence or any other claim, judgment, loss, liability, cost and expenses arising out of or connected with the Event, including any claim arising out of or connected with any illness, injury or property damage that the Minor may incur or sustain during the Event, all activities associated with the Event and while traveling to and from the site for the Event whether or not the Event actually occurs. I further expressly agree to indemnify and hold harmless Releasees and Releasees' heirs, successors, assigns, executors and administrators against loss from any further claims, demands or actions that may subsequently be brought by Minor or by any other person or persons on account of damages of any character resulting to Minor in any way from the foregoing activities. I further agree to reimburse and to make good to Releasees any loss, damages or costs Releasees may have to pay as a result of any such action, claim or demand.

House Rules. I further acknowledge and understand that Barev has established, and from time to time will establish, rules and regulations pertaining to conduct, behavior and activities of all participants in the Event, by which Minor and I agree to abide during the Event, and that Minor and I will be responsible for her/his/my failure to abide by those rules and regulations. Without limiting the generality of the foregoing, I specifically acknowledge that these rules strictly prohibit: i) the use of alcohol, tobacco products and any drugs or medications not specifically prescribed for the individual possessing them; ii) the use of foul or other inappropriate language, gestures or insults to others, or iii) any inappropriate relationships. Minor and I understand that violation of the rules can result in dismissal from Event with no refund and a requirement that I arrange for private transportation for Minor from the Event following any such dismissal.
